Refunds for accepted participant's booth fees will be made if the Johnny Appleseed Board is notified of cancellation before August 1st, 2022. After that date, NO refunds will be made. There will be a \$25 fee for every returned/bounced check or cancellation prior to August 1st.

**TARP/TENT RENTAL:** Johnny Appleseed Festival can supply an 8'x12' "Fly" or tarp or a 10'x10' tent with sides for a fee. If you do not apply for one on your application - we will not be able to supply you with one during festival. Please mark your requirements. Only (1) choice per applicant.
