Refunds for accepted participant's booth fees will be made if the Johnny Appleseed Board is notified of cancellation before August 31st, 2023. After that date, NO refunds will be made. There will be a \$25 fee for every returned/bounced check or cancellation prior to August 31st.

**EARLY BIRD FEE:** Only Two Hundred Seventy Five Dollars (\$275) if submitted postmarked by February 28th, 2023. (Rear booth fee still applies)
