Refunds for accepted participant's booth fees will be made if the Johnny Appleseed Board is notified of cancellation before August 1st, 2023. After that date, NO refunds will be made. There will be a \$25 fee for every returned/bounced check or cancellation prior to August 1st. Food vendors are required to provide a 20% split on NET profits to the festival, see food vendor information on the website for full details.
